

REGULATIONS CONTINUED

- Maximum width of vehicle excluding mirrors is 1.35 metres
- Tires must be low pressure bearing
- Vehicle must meet all safety standards with all equipment working
- Vehicle must have a braking system
- Lights (front and rear) must be on at all times
- Stop lamps and reflectors are required
- Vehicle shall be insured
- Drivers must wear a helmet
- Maximum speed is 50 kph in an 80 kph zone and 20 kph in a 50 kph zone
- Vehicle must be operated so as not to cause risk to others
- Vehicle must not emit excessive dust, noise, and/or emissions
- Vehicle to be driven on the shoulder or the right side of the road if no shoulder
- Drivers must yield to other vehicles
- Vehicle must not be driven on median strip, construction zones, or roads closed temporarily

- ATV's and off-road vehicles must not pass other motor vehicles or snowmobiles

This pamphlet summarizes the provisions of By-law Number 1954-2005-PP, as amended; a by-law to permit the operation of ATV's and Off-Road vehicles on highways owned and maintained by the Corporation of the Township of Brock. The information provided is intended only as a guide.

INTRODUCTION

The *Highway Traffic Act* was amended in 1999 to permit local municipalities to enact by-laws to permit the operation of all-terrain vehicles (ATV's) and other off-road vehicles to travel upon roads under the jurisdiction of the municipality subject to a number of rules and regulations.

Farmers and trappers are legally permitted to operate ATV's on highways provided they are licenced, the vehicle is plated, and the vehicle contains a slow moving sign.

ATV's are defined as an off-road vehicle that has four (4) wheels, has steering handlebars, a seat designed to be straddled by the driver, and is designed to carry a driver only with no passengers. Off-road vehicles include dune buggies and argos.

BY-LAW NUMBER 1954-2005-PP, AS AMENDED

By-law No. 1954-2005-PP was adopted on June 27th, 2005 to permit the operation of ATV's and other off-road vehicles on opened and maintained Township roads only between December 1st and March 31st the following year.

BY-LAW PROVISIONS

ATV's and off-road vehicles are permitted on all highways under the jurisdiction of the Township of Brock only between December 1st in a calendar year to March 31st in the following year, subject to a number of rules and regulations made pursuant to the *Highway Traffic Act*.

The operation of ATV's and off-rad vehicles is prohibited on all Regional roads and Provinvial highways except when crossing at a 90 degree angle:

- Durham Road 50
- Shoreline Road (47)
- Lakeridge Road/Osborne Street/Mara Road (23)
- Simcoe Street (15)
- Simcoe Street (2)
- Cameron Street (12)
- River Street (10)
- Durham Road 13
- Regional Highway No. 48
- Provincial Highway Numbers 7, 7/12, 12, and 48.

Further, this by-law does not authorize their use on privately owned trails (such as those used by the local snowmobile clubs) and other private property.

ATV's and off-road vehicles are not permitted on sidewalks and/or boulevards except when crossing at a 90 degree angle.

ATV's and off-road vehicles are permitted in public parks except where signed prohibited.

ATV's and off-road vehicles are prohibited between the hours of 1 a.m. and 6 a.m. within the urban areas (Beaverton, Cannington, Sunderland, and the hamlets of Gamebridge, Sonya, Port Bolster, Manilla, and Wilfrid).

REGULATIONS

The following regulations have been summarized for the purpose of convenience from the *Highway Traffic Act*. The reader is directed to Ontario Regulation 316/03:

- Drivers must be licenced
- Vehicle must be plated
- Vehicle must be less than 450 kilograms
