Bruce Power unveils \$3 billion 'Made in Ontario' plan to create jobs, support energy and health care innovation to recharge the economy

TIVERTON, ON – *July 15, 2021* – Bruce Power announced today its plan to contribute to a 'Made in Ontario' economic recovery, investing \$3 billion over the next 18 months through the company's Life-Extension Program, isotope development, and asset optimization

strategy.

This investment will create and sustain thousands of highly-skilled jobs and drive economic benefits throughout the Clean Energy Frontier region and across Ontario.

Mike Rencheck, Bruce Power's President and CEO, outlined the company's five-pillar strategy to contribute to a revitalized economy, while providing global leadership in the production of medical isotopes, contributing to Canada's Net Zero 2050 goals, and securing reliable electricity for decades to come.

"Bruce Power's Life-Extension Program continues to play a key role in stimulating the economy as Ontario moves into the recovery phase of the COVID-19 pandemic," Rencheck said. "This investment program will also ensure a steady global supply of medical isotopes and a reliable source of clean electricity that will make significant contributions to a Net Zero Ontario and Canada."

Hon. Todd Smith, Ontario's Minister of Energy, commended Bruce Power for its focus on economic recovery and commitment to Net Zero.

"Bruce Power's Life-Extension Program and Major Component Replacement Projects are key drivers supporting our post-pandemic economic recovery, with the vast majority of its multi-billion dollar investments benefitting the people, supply chains and jobs right here in Ontario," Minister Smith said. "As Canada's largest private infrastructure and clean energy project, this investment is also advancing Ontario's role as a global leader in a clean energy future."

Bruce Power's strategy to help revitalize Ontario's economy consists of five pillars:

1. **Recharging the economy through private investment.** A private investment of \$3 billion over the next 18 months through the company's Life-Extension Program, isotope development, and asset optimization strategy will enable Canada's largest privately-funded clean energy project to secure carbon-free, reliable electricity for decades to come and a stable global supply of medical isotopes.
2. **Advancing medical innovation through global isotope production.** In 2022, the company will deploy a game-changing isotope delivery system for its CANDU reactors to produce Lutetium-177, an isotope used to treat neuroendocrine tumours and prostate cancer. The company also produces Cobalt-60, used to sterilize medical devices, battle cancer and treat brain tumours.

3. **Taking action on Net Zero.** One of the largest emissions-reduction initiatives in a generation – the phase out of coal in Ontario – was made possible by Bruce Power. The company is building on this leadership role by contributing to a Net Zero Canada by 2050. In addition to providing a reliable supply of carbon-free electricity, this will be achieved by eliminating greenhouse gas emissions from its site operations by 2027; the launch of Ontario’s first Community Carbon Coalition, which will fund grassroots initiatives that both remove and offset carbon emissions; and work with a range of organizations to advance hydrogen, electrified transportation and integration of nuclear with other resources.

4. **Securing highly skilled jobs for Ontarians.** Over 95 per cent of Bruce Power’s supply chain is Ontario-based, providing economic growth and supporting 22,000 direct and indirect jobs annually. Bruce Power continues to strengthen its ‘Made in Ontario’ supply chain to support the Clean Energy Frontier program in Grey, Bruce and Huron counties, while pursuing broader opportunities across the province.

5. **Advancing the future of nuclear.** Ontario’s nuclear industry is a key driver in Canada’s clean energy future. Through its existing CANDU fleet, robust nuclear supply chain, and key global supply of medical isotopes, Ontario is a world-leader in nuclear. Bruce Power, in collaboration with a range of partners, and the Bruce County-based Nuclear Innovation Institute will launch the Future of Nuclear Program to support the positioning of Ontario as a global nuclear leader.

“These pillars will advance Ontario’s economic recovery as we make historic and long-term investments in Canada’s single largest site for clean electricity, which also support tens of thousands of jobs annually in Canada,” Rencheck said.

Rocco Rossi, President of the Ontario Chamber of Commerce, acknowledged the positive impact the Ontario nuclear supply chain has on the province’s economy.

“A strong nuclear industry is essential to a strong economy in Ontario,” Rossi said. “Ontario’s nuclear sector injects billions into the economy every year, providing low-cost, reliable and carbon-free electricity that our businesses need to stay competitive in the world market, and life-saving medical isotopes which are vital resources in the global medical community.”

Expanding the narrative: Providing space for new voices

There is an important public dialogue that's been unfolding for some time – about whose history is told, about Indigenous history, gender, people of colour and the economically disenfranchised, and others whose stories have been overlooked or intentionally omitted.

More recently, we have been facing parts of our history that have given harm to others and for which we feel shame. Equally importantly, it is about those parts of our history that have shown our commitment to respect human rights and improve quality of life. It's about what we protect and how such choices are made, about decolonizing history, about building bridges of reconciliation and creating a sense of belonging for everyone.

Changing and challenging the long-standing narrative of our history requires deep reflection and a concerted effort to make space for new voices to be heard.

In September 2018, I wrote [Shifting the narrative](#), an article for the Trust's magazine *Heritage Matters*. Recent events show that it continues to remain relevant and timely, and I would like to share these parts of it with you.

“Over the past several years, the Trust has made a concerted effort to bring forward the stories of all of the people of Ontario – providing a forum to look back over more than 10,000 years at the people who have lived here, raised families, created communities, traded and often fought with and for one another. The goal of our work now is to re-define the narrative – to ensure that the heritage we protect and the stories we tell are a respectful, accurate and authentic portrayal of the peoples who have lived on and contributed to this land known as Ontario.

The Trust has designed programs and partnerships to create a meaningful public dialogue and a more inclusive discussion around heritage. We are working with communities across the province to share their own stories in their own voices, to celebrate the diversity of experiences, languages, customs and perspectives of different people and different places.

In the work that the Trust does with Indigenous communities, it has been necessary to search past the well-told, long-taught history of the settlers to understand the complex and successful civilizations of the Anishinaabek, Haudenosaunee and Wendat that have existed here for more than 10,000 years. We have had the opportunity to hear from Elders and knowledge keepers about the values they place on the land. Those discussions have enriched our understanding and our actions. We have also recognized that this important history is preserved not in books or on plaques but in the very act of sharing it from generation to generation. What happens when we see their worldview as different and no less valid than any of those that came with settler societies or with immigrants who have arrived since? What can we do to tell their rich and relevant history, their ongoing and continuing contributions to health and science, to sports and culture, to business and politics? Who are the heroes from those communities who have yet to be recognized and celebrated?

At Josiah Henson's home, Uncle Tom's Historic Site in Dresden, we have recently re-examined the reality of slavery in Canada so that we can better understand its influence on what has followed. We look at the Dawn Settlement as an example to explore themes of freedom and social justice. So often, we learn the stories of Harriet Tubman, Josiah Henson, Mary Ann Shadd and their work with the Underground Railroad, but they are too often frozen in time and place, lauded for their bravery in the search for freedom and still not treated as equals in the annals of history. The rest of the Black community remains largely nameless, their sites of memory and the stories of their ancestors forgotten in time. After 400 years of presence of the Black community, they and their contributions should be respected, recognized as intrinsically valuable.

There are entire populations of our society whose contributions to our history and heritage

have been overlooked – women, immigrant communities and refugees, racialized people and the LGBTQ2, to name a few.

If it's true that we protect what we value, then we should revisit the frameworks and criteria that we use to determine what has heritage value and proceed with an approach that is inclusive and multifaceted and that reflects our diversity and complexity.”

peoples and stories:

- **[Ottawa Main Mosque](#)**: The distinctive Ottawa Mosque is the first and the oldest mosque in the city and one of the oldest in Canada.
- **[Saint Joseph's Indian Residential School Memorial](#)**: This memorial in Thunder Bay serves to honour the survivors and to remember the children who didn't go home.
- **[Uncle Tom's Cabin Historic Site](#)**: Josiah Henson, an African-American who arrived in Canada via the Underground Railroad, purchased this property in 1841 and established the Dawn Settlement near what is now the town of Dresden. Today, the site is a museum, owned and operated by the Ontario Heritage Trust.
- **[Griffin House National Historic Site](#)**: Griffin House is a modest 1827 wood-frame residence in the Georgian style, purchased in 1834 by Eneals Griffin and his wife Priscilla – both born as slaves in Virginia, but who escaped to Canada. Today, it stands as a testament to the determination of African-American men and women who escaped slavery and found peace in Ontario.
- **[The ArQuives](#)**: The ArQuives was established in Toronto to aid in the recovery and preservation of the histories of Canada's LGBTQ2+ people.

Enrichir le récit : Offrir un espace aux nouvelles voix

Depuis un certain temps, un important dialogue public se déroule sur les sujets suivants : les personnes dont l'histoire est racontée; l'histoire des autochtones; le genre; les personnes de couleur et les personnes privées de leurs droits économiques; d'autres

personnes dont l'histoire a été négligée ou intentionnellement omise.

Plus récemment, nous avons été confrontés à des pans de notre histoire qui ont causé du tort à d'autres personnes et dont nous avons honte. Fait tout aussi important, il s'agit des pans de notre histoire qui ont montré notre engagement à respecter les droits de l'homme et à améliorer la qualité de vie. Il s'agit de ce que nous protégeons et de la manière dont les choix sont faits pour décoloniser l'histoire, construire des ponts de réconciliation et créer un sentiment d'appartenance pour tous.

Changer et remettre en question le récit traditionnel de notre histoire exige une réflexion approfondie et un effort concerté pour permettre à de nouvelles voix de se faire entendre.

En septembre 2018, j'ai écrit [Revoir le point de vue historique](#), un article pour le magazine *Questions de patrimoine* de la Fiducie. Les événements récents montrent qu'il reste pertinent et opportun, et j'aimerais partager les parties suivantes avec vous.

« Depuis plusieurs années, la Fiducie a mis en œuvre des efforts concertés pour dévoiler l'histoire de tous les peuples ontariens et retracer la vie des personnes qui, en plus de 10 000 ans, ont fondé une famille, créé des communautés, commercé et souvent combattu les unes aux côtés des autres et pour les autres. Notre travail a maintenant pour but de redéfinir les faits exposés, pour veiller à ce que le patrimoine que nous protégeons et les histoires que nous racontons dressent un portrait authentique, fidèle et Revoir le point de vue historique Par Beth Hanna La Fiducie a noué des partenariats avec les communautés autochtones afin de protéger les terres ayant une valeur sacrée et un intérêt culturel qui sont menacées par l'aménagement. Questions de patrimoine 3 respectueux de celles et ceux qui ont vécu sur ces terres et apporté leur pierre à l'édifice qu'est aujourd'hui « l'Ontario ».

La Fiducie a mis sur pied des programmes et des partenariats visant à instaurer un dialogue public constructif et à mener une discussion plus inclusive sur la question du patrimoine. Nous collaborons avec les communautés de toute la province dans le but de raconter leur histoire avec leurs propres voix, de célébrer la diversité des expériences, des langues, des coutumes et des points de vue parmi des peuples différents venus d'horizons divers et variés.

Dans le cadre de son travail auprès des communautés autochtones, la Fiducie a dû creuser au-delà de l'histoire bien connue des colons, que l'on raconte de longue date, pour comprendre les civilisations complexes et florissantes des Anishinaabeg, des Haudenosaunee et des Wendat qui vivent ici depuis plus de 10 000 ans. Nous avons eu l'occasion d'écouter le témoignage d'aînés et de gardiens du savoir à propos des valeurs qu'ils prêtent à la terre. Riches d'enseignements, ces discussions nous ont éclairés et ont guidé nos actions. Nous avons également pris conscience que ces récits importants ne sont pas immortalisés dans des livres ou sur des plaques, mais survivent par la transmission de génération en génération. Que se passe-t-il lorsqu'on constate que leur vision du monde est différente et tout aussi valable que celle importée par les colons ou les immigrants arrivés après eux? Que pouvons-nous faire pour raconter leur histoire riche et pertinente, pour exposer leur contribution permanente dans les domaines de la santé et de la science, du sport et de la culture, du commerce et de la politique? Qui sont les héros méconnus de ces communautés, à qui l'on ne rend pas encore hommage?

Sur le Site historique de la Case de l'oncle Tom, à Dresden, foyer de Josiah Henson, nous avons récemment réexaminé la réalité de l'esclavage au Canada afin de mieux comprendre son influence sur les faits ultérieurs. La création de l'établissement Dawn nous a servi d'exemple pour explorer les thèmes de la liberté et de la justice sociale. Nous étudions tous à maintes reprises l'histoire de Harriet Tubman, de Josiah Henson, de Mary Ann Shadd et leur contribution au chemin de fer clandestin, mais ce récit est trop souvent figé dans le temps et dans l'espace. Applaudis pour la bravoure dont ils ont fait preuve

dans leur quête de liberté, ils ne sont toujours pas traités en égaux dans les annales de l'histoire. Le reste de la communauté noire demeure en grande partie anonyme, les sites dépositaires de leur mémoire et l'histoire de leurs ancêtres étant tombés dans l'oubli. Après 400 ans de présence de la communauté noire, il convient de respecter ses membres et leurs contributions et de reconnaître leur valeur intrinsèque.

Les contributions historiques et patrimoniales de pans entiers de notre société (femmes, communautés immigrantes, réfugiés, populations racialisées et membres LGBTQ2, pour ne citer que quelques exemples) ont été ignorées.

Si nous protégeons vraiment ce que nous valorisons, nous devons revoir les cadres stratégiques et les critères employés pour déterminer les objets porteurs d'une valeur patrimoniale et offrir une représentation inclusive des nombreuses facettes du patrimoine de la province qui reflètent notre diversité et notre complexité. »

Explorer le nouveau site Questions de patrimoine

La diversité par les portes ouvertes

Portes ouvertes Ontario en ligne présente maintenant des expériences en ligne provenant de près de 300 lieux dans la province. Nous avons sélectionné ci-dessous une liste des lieux qui mettent en valeur des peuples et des histoires diversifiés :

- **Mosquée principale d'Ottawa** : La mosquée distinctive d'Ottawa est la première et plus vieille mosquée de la ville et l'une des plus vieilles du Canada.
- **Pierre commémorative du pensionnat indien de Saint-Joseph** : Cette pierre commémorative à Thunder Bay rend hommage aux survivants et permet de se souvenir des enfants qui ne sont pas rentrés chez eux.
- **Site historique de la Case de l'oncle Tom** : Josiah Henson, un Afro-Américain qui est arrivé au Canada en empruntant le chemin de fer clandestin, a fait l'acquisition de cette propriété en 1841 et y a fondé l'établissement Dawn, près de ce qui est maintenant la ville de Dresden. Aujourd'hui, le lieu est un musée, détenu et exploité par la Fiducie du patrimoine ontarien.
- **Lieu historique national de la maison Griffin** : La Maison Griffin est une modeste résidence de 1827 à ossature de bois construite dans le style géorgien. Elle a été achetée en 1834 par Eneals Griffin et sa femme Priscilla – tous deux nés esclaves en Virginie, mais qui ont fui au Canada. Aujourd'hui, la maison témoigne de la

détermination des Afro-Américains et des Afro-Américaines qui ont échappé à l'esclavage pour trouver la paix en Ontario.

I am writing to you today to inform you that the Ministry of the Environment, Conservation and Parks has extended the timeline for public comment on the following proposals posted on the Environmental Registry of Ontario:

1. **Proposed Land Use Compatibility Guideline**
2. **Proposed Odour Guideline**
3. **Updating the ministry's Compliance Policy to focus on high-risk incidents and publicly posting the Referral tool and Service Standards**

The deadline for public comment on these proposals was July 3, 2021, but we've extended the deadline to August 6, 2021 (34 days).

The ministry has received feedback from stakeholders requesting an extension to enable additional time to coordinate and submit comments on the three proposals. We understand the challenges that many stakeholders are facing, and as such, have extended the public comment period.

The ministry is not proposing legislative changes through the Land Use Compatibility Guideline, Odour Guideline or updated Compliance Policy. 4. **Administrative Monetary Penalty Expansion – Stakeholder Consultations**

The ministry is expanding our ability to issue administrative monetary penalties, currently known as environmental penalties, to more violations and to our entire regulated community, an estimated 150,000 entities. This includes individuals, small businesses and large corporations as well as public entities like municipalities and crown corporations. Currently, these penalties can be applied when certain environmental violations, such as spills and unlawful discharges, occur at about 140 industrial facilities.

We are now inviting you to participate in an engagement session where we will present proposed approaches on the details of the new administrative monetary penalties framework for environmental violations, to seek your feedback prior to drafting regulations. The engagement session will be delivered online and offer an opportunity for you to provide direct input. 5. **Re-Launch of Enhanced Ontario Community Environment Fund**

Funds collected from administrative monetary penalties will continue to be dedicated to the Ontario Community Environment Fund, to support environmental improvement projects in the regions of Ontario where the violations occurred. Projects will support increased environmental restoration, and resilient communities and local solutions to environmental issues. Projects will be assessed through a competitive process, based on their positive environmental and community benefits as well as the quality of the project design.

More information about the enhanced Ontario Community Environment Fund and the 2021 call for applications will be announced soon. The application period is expected to be open from early May 2021 to late June 2021 and will make funds available, collected from penalties between 2016-2019. Local organizations can apply for the funding available based on the region where they are located:

- Northern Region: \$475,009
- Southwest Region: \$306,151
- Eastern Region: \$62,864
- West-Central Region: \$43,298
- Central Region: No funding available this round because the value of penalties collected did not meet the minimum funding threshold of \$5,000.

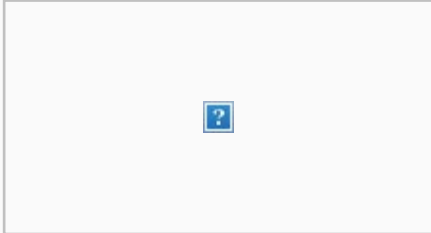

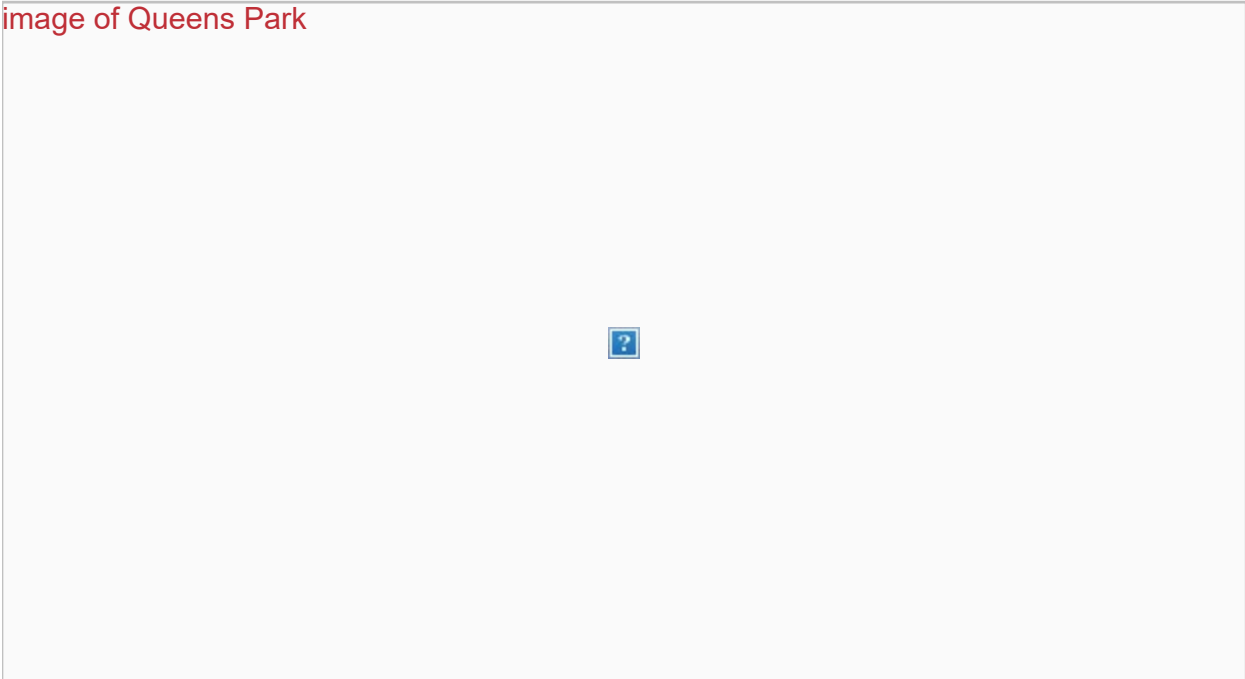

Advocacy Update: Submission to the Province's Strengthening Municipal Codes of Conduct consultation

As you are aware, the Province launched [consultations](#) on strengthening accountability for municipal council members.

The consultation was based on three guiding questions:

- What changes or mechanisms are needed to better hold council members accountable for municipal code of conduct violations?
- How can codes of conduct be more effectively enforced?
- Are a broader range of penalties for codes of conduct violations needed?

In April, we asked you, our members, to provide feedback on some key questions to help inform our

submission. Your feedback also helped to inform roundtable discussions between our Board and the former minister responsible for the consultation.

The content of our final submission is based on the principle that protecting the health, safety and well-being of municipal staff, elected officials and the public is paramount. Our submission is framed to emphasize that municipal staff should not be put in the awkward position of enforcing codes. We also emphasize that the Province must think about implementation issues and provide guidance to support municipal staff on any new accountability mechanisms.

We also took the opportunity in our submission to address other considerations for strengthening accountability and transparency on the topics of council-staff relations, operational and administrative burden, and improving standards for integrity commissioners — issues that we have raised previously and continue to focus our advocacy efforts on.

Thank you to everyone who contributed feedback. We look forward to continuing to work together with you and the Province on strengthening accountability to build a safer and stronger municipal sector.

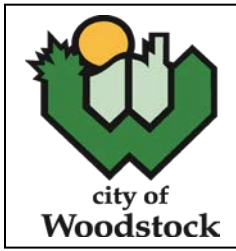

Whereas the Federal government could look at other means to slow down the rapidly escalating housing costs to improve housing affordability;



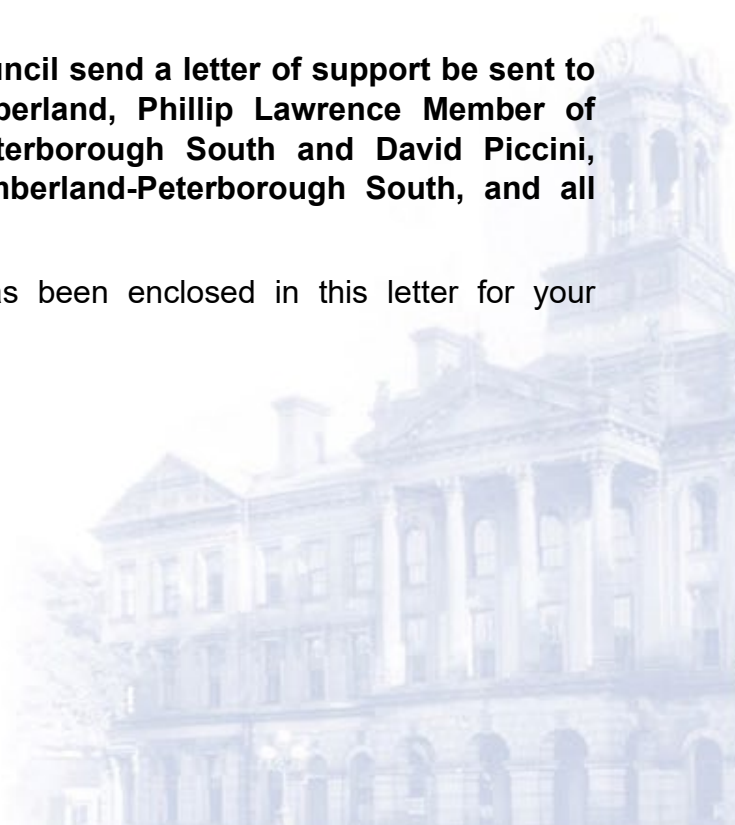

The Municipal Council of the Town of Fort Erie at its meeting of May 31, 2021 passed the following resolution:

Whereas primary residences are currently exempt from a capital gains tax, and

Whereas currently secondary and additional non-primary properties are subject to capital gains, and

Whereas the Federal Government is currently looking into a primary residence capital gains tax as they have recognized that affordable housing has become a serious issue in Canada, and

Whereas smaller communities including the Town of Fort Erie are seeing unprecedented higher selling prices that are outpacing prices in larger cities, and

Whereas many hard-working Canadians who have only a primary residence with no additional non-primary homes count on their home equity as financial aid to apply to upsizing or downsizing their home depending on their personal situation, and

Whereas a change in taxation to primary residences would be a significant financial blow to Canadians and would create an unfair, two-tiered taxation which could lead to depleted savings, inter-generational disparities, disparities among diverse groups such as seniors who may have a significant portion of their savings vested in their primary residence, as well as, reducing the ability of home ownership thereby a further, higher need for rentals, and

Whereas the Federal government could look at other means to slow down the rapidly escalating housing costs to improve housing affordability;



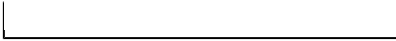

Facts Matter When It Comes To Safety

When it comes to safety, facts matter.

It's something Ontario's nuclear industry takes very seriously. It drives every decision we make and every activity we do. Unlike groups like the Ontario Clean Air Alliance, facts

matter in our sector. That's why it's disappointing to see continued attempts (like their latest email today) to sensationalize recent information in an attempt to legitimize their erroneous policy goal to phase-out nuclear in Ontario, and their short-term focus of removing Pickering from service.

Here are the facts: as part of ongoing planned inspection, testing, analysis and maintenance activities at Bruce Power, some higher-than-anticipated readings were recently observed in one of the ways the condition of pressure tubes are analyzed in two units, both of which are not currently operating. Unit 3 is presently in a routine inspection and maintenance outage, while Unit 6 is undergoing its Major Component Replacement, where all pressure tubes are being replaced.

An immediate review of this following rigorous processes and concluded there was no impact on the safety of the units. All six Bruce units that are currently operating have recently undergone similar inspections and demonstrated fitness for service.

This was proactively shared with the Canadian Nuclear Safety Commission, and with other CANDU operators to ensure a collective understanding from these inspection activities through the CANDU Owners Group. Recent inspection and maintenance outage campaigns have demonstrated the ongoing safe operation of the pressure tubes, which will continue to be thoroughly, inspected in future planned outages.

These inspection activities form the basis of common tools that strengthen and evolve and have a proven track record of ensuring safety. These inspection results will be used alongside a large set of information collected over many years, to continue to build on the activities routinely performed to demonstrate continued safe, reliable operation.

There is a reason that our nuclear units undergo frequent outages and refurbishments – it is PART of Canada's world-class safety regime which has an unparalleled 60-year track record of success, it is not a threat to it. It is this commitment to safety which will ensure Ontario's nuclear fleet will continue to play a key role in providing emissions-free power to help Canada meet its Net-Zero climate change targets, provide medical isotopes to benefit health care and patients around the world, and continue to innovate to meet the clean energy needs our future demands.
