


Ontario announces additional workplaces that can reopen

On May 14, the Ontario government announced the <u>retailers</u>, <u>seasonal businesses and health and community service providers who will be permitted to open or expand their services</u> on <u>Tuesday</u>, <u>May 19</u>, <u>2020</u> at 12:01 a.m., provided that the general trend on health indicators continues to improve as part of the first stage of the government's reopening framework. The workplaces opening as part this stage are well-positioned to put workplace safety measures in place and get more people back to work, while not overburdening public transit and other services.

Minister MacLeod convenes COVID-19 Advisory Councils

NEWS May 12, 2020

TORONTO — The Ontario government is engaging partners in the heritage, sport, tourism and culture sectors in order to gather critical feedback on how best to reopen the economy. This input will inform decisions as the government implements its Framework for Reopening our Province document which was released in April 2020.

Yesterday, Lisa MacLeod, Minister of Heritage, Sport, Tourism and Culture Industries, was joined by Premier Doug Ford to speak with chairs from sector-specific Ministerial Advisory Councils. These leaders represent a broad range of organizations and are best positioned to identify opportunities for a sector-led response to the economic challenges caused by the outbreak. These Ministerial Advisory Councils will meet on a regular basis starting immediately and provide their written feedback to the ministry later this month.

"The impact of COVID-19 has been devastating for Ontario's heritage, sport, tourism and culture industries with an economic loss in the billions," said Minister MacLeod. "Through these Ministerial Advisory Councils, I will work directly with sector leaders to discuss the challenges they face, and ensure their industries are well positioned for a faster re-emergence and successful recovery from the effects of the outbreak."

Survey 4.0 results

Thank you to everyone who continues to provide TIAO with real time data on the impact of the COVID-19 response.

The report from Survey 4 includes the top level data insights on the impact across the province. The data collected from Survey 4 indicates that the greatest risks to tourism operations are:

- Uncertainty around when they will be able to reopen
- Temporary closures becoming permanent
- · Ineligibility for existing government aid
- Insurmountable debt levels

Survey 5.0 is now live

Thank you to every one of you who has filled out the TIAO survey, every 3 weeks since the beginning of the COVID-19 pandemic.

It can feel as though answering the same questions in these surveys is an exercise in futility. But, this data really does matter—what you are experiencing is important.

The impact of the COVID-19 pandemic on tourism businesses is historic and unprecedented. TIAO needs to leverage the power of the collective impact of this, to tell all levels of government what tourism

TIAO is using the survey data as well as data from consultations, to inform their recommendations to all levels of government in Canada.

They recognize that the tourism industry is facing exponential decline, and therefore requires unprecedented levels of financial aid.

Their recommendations focus on the above survey findings, and the need for government to provide immediate financial stimulus for lost revenues and wages.

This would be part of an economic recovery package that provides financial relief, rather than a deferral of debt.

The Event Safety Alliance presents: the COVID-19 Reopening Guide

FEO thanks their friends at Event Safety Alliance and all those who contributed to developing the Event Safety Alliance Reopening Guide. Along with your local public health requirements, you can use this guide to start planning for your venues and events.

As municipal officials begin to allow small groups of people to gather in public even while the fight against COVID-19 continues—there is a tremendous need for guidance around how small events and venues can reopen as safely as possible under these incredibly challenging circumstances.

In response, the Event Safety Alliance today released <u>The Event Safety Alliance</u> <u>Reopening Guide</u>. At this link, you can download the guide, listen to the podcast and submit questions and feedback for future revision.

The Reopening Guide addresses health and sanitary issues that event and venue professionals need to consider in order to protect both patrons and workers. Since there is still insufficient testing, no contact tracing, and no vaccine against COVID-19, this guidance is particularly detailed.

The first edition is tailored to be especially useful for event professionals reopening the smallest events with the fewest resources available to mitigate their risks, since in every municipal reopening plan these will be allowed to reopen first.

"There is no guarantee of an illness-free event even if you follow everything in this Reopening Guide. It is indisputable, however, that planning, training, and implementing reasonable health and safety measures are the best ways to not only protect the viability of live events and the people who create them, but also to inspire our patrons to return to the places where we make the magic happen."

Regional Relief and Recovery Fund (RRRF)

TIAC is pleased to share information concerning a new funding program that will be delivered through Canada's six Canada's Regional Development Agencies (RDAs) who are now accepting applications under the <u>Regional Relief and Recovery Fund (RRRF)</u>. TIAC has long been advocating for financial support for those small, seasonal, rural and other SMEs who have not been able to access existing government support measures.

On **April 17**, **2020**, Prime Minister Justin Trudeau <u>announced new, targeted measures</u> to protect jobs and provide more support to businesses and communities impacted by COVID-19. During the webinar co-hosted by Destination Canada and TIAC on **May 12**, the Honourable Minister Melanie Joly told participants that this program was imminent. As part of these

measures, the national \$1 billion RRRF provides funding to small- and medium-sized enterprises (SMEs) that are unable to access the government's existing support measures, including Destination Marketing Organizations (DMOs), and access to capital for rural businesses and communities.

This new fund, officially launched **May 13, 2020**, is being delivered by Regional Development Agencies (RDA) across the country to help organizations continue their operations and position themselves for a successful recovery.

Funding amounts vary by RDA, and fall under two categories.

- \$675 million to support regional economies, businesses, organizations and communities in regions all across Canada;
- \$287 million to support the national network of Community Futures Development Corporations, which will specifically target small businesses and rural communities across the country.

Dear Prime Minister Trudeau:

This is to advise that City Council, at a special electronic meeting held on May 11, 2020, passed the following resolution regarding universal basic income:

"WHEREAS The World Health Organization (WHO) on March 11, 2020 declared COVID-19 a pandemic, pointing to the growing number of cases of the coronavirus illness around the world and the sustained risk of further global spread; and,

WHEREAS in response to the COVID-19 pandemic, the Province of Ontario and the City of Kitchener have declared a state of emergency under the Emergency Management and Civil Protection Act; and,

WHEREAS the City of Kitchener has approved the Early Economic Support Plan, which provides financial and economic support measures to help reduce the financial strain on citizens and businesses during the COVID-19 pandemic; and,

WHEREAS Statistics Canada has reported that the unemployment rate has risen to 7.8 per cent, with 1,011,000 jobs lost in March 2020, and that the COVID-19 pandemic has impacted the employment of 3.1 million Canadians; and,

WHEREAS the Federal government has announced \$82 billion in relief funding for the COVID-19 Economic Response Plan, utilizing tax deferrals, subsidies, loans, and credits to support citizens, businesses, and industries; and,

WHEREAS according to a 2018 Parliamentary Budget Office report, a Canada-wide basic income of the type previously piloted in Ontario would have an annual net cost of \$44 billion; and,

WHEREAS a universal basic income would likely have many positive effects, including reducing poverty, reducing strain on health care and social assistance systems, supporting businesses and the economy, reducing crime, as well as reducing administrative complexity and creating efficiencies for those in need of financial and economic support measures;

THEREFORE BE IT RESOLVED that the Council of the City of Kitchener urges the Ontario Provincial government to pursue a partnership with the Federal government for the establishment of a universal basic income;

BE IT FINALLY RESOLVED that this resolution be forwarded to the Right Honourable Prime Minister of Canada; the Honourable Premier of Ontario; the Minister of Children, Community and Social Services; the Minister of Municipal Affairs and Housing; the Association of Municipalities of Ontario; the Local Members of Provincial Parliament; the Region of Waterloo; all Municipalities within the Province of Ontario; and, the Federation of Canadian Municipalities."



AMO COVID-19 Update – Municipal Fiscal Request, Emergency Orders, Pandemic Pay, LTC Homes Commission, Extended School and Child Care Closures, and Summer Camps

Municipal Fiscal Request

AMO today signed a joint letter with CUPE Ontario calling on the Province and the federal government to work together to provide much needed financial assistance to Ontario municipalities to assist with the COVID-19 emergency and recovery. The letter echoes AMO's May 14th letter to Premier Ford and Prime Minister Trudeau.

Extension of Emergency Orders

Today the Ontario government, in consultation with the Chief Medical Officer of Health, has <u>extended</u> all emergency orders currently in force until May 29, 2020. This includes the closure of bars and restaurants except for takeout and delivery only, restrictions on social gatherings of more than five people, and staff redeployment rules for long-term care homes and congregate settings like retirement homes and women's shelters.

The Province has officially entered the first stage of its <u>Framework for Reopening the Province</u>. Effective today, the government is permitting the reopening of some <u>outdoor recreational amenities</u>, including outdoor sports facilities and multi-use fields, off-leash dog areas, and outdoor picnic sites, benches and shelters in park and recreational

areas. The government is also allowing drive-in <u>religious gatherings</u>, and <u>public</u> <u>libraries</u> to provide curbside pickup.

Note that outdoor playgrounds, play structures and equipment, fitness equipment, public swimming pools, splash pads and similar outdoor water facilities will remain closed until later stages of the Province's reopening plan. The full list of businesses that can open is listed here. Further details will be shared as they become available.

Pandemic Pay Update

Late on Friday, May 15th, the Province updated its <u>Pandemic Pay website</u> to say that "As of May 15, ministries have contacted all eligible employers, service delivery partners or employer associations".

This raised confusion with many of our members as they, as municipal employers of public health, paramedic services and housing/shelter staff, had not yet been contacted by the Province on this program. We believe that the Province may have been referencing some very initial discussions on the pandemic pay program they have had with AMO staff, the Ontario Municipal Human Resources Association, and the City of Toronto as the above-mentioned contact with municipal employers.

We are awaiting further information on the program design and the eligibility criteria – which, of course, will form the crux of the program. At this point, the AMO update of May 7th is still our best understanding of the program, "Under this temporary program, municipal governments have eligible full and part-time front-line staff who work in the following program areas: public health, paramedic services, long-term care homes, and housing and shelters. This will involve three ministries and four program areas".

That said, we are aware of a May 15th letter from the Deputy Minister, Ministry of Long-Term Care, Richard Steele, to Long-Term Care Home Licensees regarding their temporary pandemic pay programs. This letter indicates that the Ministry's funding will be through the Licensees' Direct Funding Agreements. Further program policy will outline the specific funding program requirements, and the funding will be subject to accountability and reporting requirements. Deputy Minister Steele noted that additional details regarding direct funding allocations and the detailed program policy will be communicated at the beginning of June and that it anticipated that the money would begin flowing as soon as possible.

As noted, we are not aware of any similar program details available yet for public health, paramedic services, long-term care homes, and housing and shelters employers. As this information becomes available, either by program area, ministry, or in an integrated municipal approach, we will update members immediately.

Independent Commission into Long-Term Care

Today the Minister of Long-Term Care, Dr. Fullerton, announced that the Province will be launching an independent non-partisan commission into Ontario's long-term care system to begin in September. Over the next few months, the government will be

finalizing details of the commission including terms of reference, membership, leadership of the commission, and reporting timelines.


The Commission is expected to examine the impact of and the response to COVID-19 in long-term care. Specifically, the government has asked for guidance on how to improve the long-term care system and better protect residents and staff from any future outbreaks. We will provide more information as it becomes available.

Updates on Schools, Child Care, and Summer Camps

The Province announced that <u>publicly funded schools</u> are closed for the rest of this 2019/20 school year. The government stated that it is planning for the reopening of public schools for the 2020-21 school year, the gradual reopening of child care when the Province is ready to move to Stage 2 of the *Framework for Reopening the Province*, and the opening of summer day camps subject to the continuing progress of key public health indicators. Overnight camps will not be permitted to operate in the summer of 2020.



First Quarter Stats

Emergency calls, violent crimes and motor vehicle collisions all decreased in Durham Region in the first quarter of 2020.

Deputy Chief Todd Rollauer provided the Board with a statistical report from the first quarter of 2020. Comparing the first quarter of 2020 to the first quarter of 2019, violent crime has decreased 9 per cent, or by 103 incidents. The decrease has been seen in almost all violent crime types, including stabbings and commercial robberies.

Property Crimes are up 10 per cent due to increases in Theft Under \$5,000 and Fraud calls.

Overall, calls for service have increased 2 per cent to 27,345 in the first quarter, despite a 4 per cent drop in Emergency Calls. Urgent and Routine calls were up. Motor Vehicle collisions are down 12 per cent, or 311 incidents.

Since the state of emergency was declared in mid-March, Violent Crimes are down 30 per cent and Property Crimes are down 23 per cent.

Force Seldom Used by the DRPS

The annual Use of Force (UOF) report for 2019 showed the DRP rarely used force during thousands of interactions with the public. In fact, force was used far less than 1 per cent of the time.

With 102,189 calls for service in 2019, UOF options were employed in only 312 incidents (only 0.31 per cent of the time). This is consistent with the five-year average of deployments. In the 312 incidents, there were no injuries reported to the subject or a third party 92 per cent of the time. This speaks to the training and professionalism of police officers.

Officers discharged their firearms only 22 times in 2019, the lowest level seen in five years. Almost all involved a wounded animal.

The Cost of COVID

A financial report indicated that the COVID-19 pandemic has cost the police service about \$975,000 in unbudgeted expenses.

These unexpected costs include purchasing more Personal Protective Equipment (PPE), additional cleaning and disinfecting of vehicles and buildings, as well as additional HR support resources for employees.

As well, there has been a loss of projected revenue through impacts on the Paid Duty program, police record checks and the alarms program.

In order to balance the 2020 budget, the Chief indicated that steps have already been taken to reduce costs, including a freeze on all discretionary spending unless approved by the executive team. Savings will also be found in other parts of the budget to offset these unexpected expenses.

The Service is still anticipating a break-even budget by the end of the year.

More Officers Trained on CEWs

More DRPS officers have received training in the use of Conducted Energy Weapons (CEWs), a less lethal option that has helped resolve dozens of incidents peacefully.

In 2019, the DRPS Police Education and Innovation Centre (PEIC) trained 203 new users on the CEW, bringing the total number of trained officers to 717. The PEIC is committed to training all front-line officers on the CEW and replacing the older version of the Taser with a newer model.

DRPS officers only deployed the devices 8 times in the first quarter of 2020, down from the 19 deployments in the first quarter of 2019.






