Dear Minister Clark:

At a special meeting of council held on August 24, 2020, members discussed concerns regarding the 2018 municipal election.

In the last six weeks of the 2018 municipal election in Wollaston Township, seasonal property owners presented signed leases with family members for sleeping cabins, bunkies and sheds. The \$100.00 leases added a significant number of new non-resident electors to the voters' list.

Although concerns were raised regarding the Township's Comprehensive Zoning Bylaw and non-use of the standard lease form, the leases were used as eligibility, allowing the children of seasonal property owners access to a Township election for the first time.

Because this gave the appearance of a pay to play campaign, and because the leases were with family members, and because no people actually lived in these structures that lacked hydro, running water and washroom facilities, this was reported to the OPP, who have a duty to enforce the rules and regulations of the *Municipal Elections Act*.

The OPP did not proceed with charges because they said there was no case law.

**BE IT RESOLVED**, that the Council of Wollaston Township ask Minister of Municipal Affairs and Housing, the Hon, Steve Clark, to review the *Municipal Elections Act* and provide amendments to ensure that loopholes are closed on any pay to play schemes in rural communities where non-resident electors are permitted to participate in elections so that \$100.00 leases do not turn into ballots for garden sheds.

AND BE IT FURTHER RESOLVED, that the County of Wollaston Township ask the Minister of Municipal Affairs and Housing, the Hon. Steve Clark, to review the Municipal Elections Act and provide amendments to provide clearer, stronger wording, to assist municipal Clerks in addressing issues to allow for a more definitive decision to be made when adding names to the voters' list.

AND BE IT FURTHER RESOLVED, that Council of Wollaston Township ask the Minister of Municipal Affairs and Housing, the Hon. Steve Clark, to ensure that there is a clear and accessible way to report election fraud.

AND BE IT FURTHER RESOLVED, that Council of Wollaston Township ask the Minister of Municipal Affairs and Housing, the Hon. Steve Clark, to ensure that the rules described in the Municipal Elections Act are actually enforceable even if there is not current case law.

AND BE IT FURTHER RESOLVED, that support for this resolution be sent to Premier Doug Ford, Daryl Kramp, M.P.P. for Hastings-Lennox and Addington, all Ontario Municipalities and the Association of Municipalities of Ontario.

MISSISSAUGA, Ontario – September 21, 2020 – The Association of Municipal Managers, Clerks and Treasurers of Ontario (AMCTO) is pleased with the Province's announcement regarding the introduction of legislation that would create a single register of voters for municipal and provincial elections to take effect January 1st, 2024 ahead of the 2026 municipal election.

The accuracy of this list is *essential* to AMCTO members, who are responsible for administering local government elections. This is particularly important should alternative voting mechanisms such as internet voting or wider mail-in voting be utilized to administer an election during an emergency such as the COVID-19 health pandemic.

"We are pleased to see the government take action after years of advocacy on behalf and by our members," says AMCTO President, Rob Tremblay. "While the 2024 timeframe is disappointing, as Returning Officers are preparing for the next municipal election in 2022, AMCTO appreciates the opportunity this would provide the Association to collaborate with Elections Ontario."

This has been a leading issue for AMCTO members since 2004. After conducting research and collecting feedback from members, the Association released two position papers supporting the need for transformational change to the municipal voters' list. In April 2019, AMCTO supported the recommendation of Ontario's Chief Electoral Officer to make Elections Ontario responsible for municipal voters' list.

With 2,000+ members in nearly every municipality, AMCTO's membership includes municipal clerks who serve as municipal chief electoral officers in their respective communities and who are charged with ensuring the integrity of municipal elections. AMCTO will continue to work with members on this and will be monitoring the progress of the Bill.

My name is Maureen Nicitopoulos and I reside at 191 Nine Mile Road in Beaverton. My husband and I have two children and have been residents of Beaverton since 2013.

I have been in the social service field for more than fifteen years in a different Municipality. I support people in the community who are homeless or at risk of homelessness by providing wrap around supports and referrals to appropriate programs and services. I have extremely strong concerns about what your housing plan is for these at risk Individuals. Beaverton has no transportation (both transit or taxi), no grocery store that is within walking distance, no police presence, lack of employment opportunities, lack of drop in centres for mental health and addiction, and no social services office. Moving at risk individuals to a community that lacks all the mentioned resources and probably more will create isolation. As you may imagine with my employment I am one for inclusiveness and diversity in our community. I am passionate in my advocacy for individuals who are homeless, at risk of homelessness and/or experiencing issues surrounding mental health and addiction. I am unable to be quiet when I see people being moved to what only feels like a "dumping ground". I would like to understand more what your thoughts are on why Beaverton would be the place of choice in Northern Durham to house 50 at risk individuals.

The Trust is committed to challenging the traditional narratives of our history and how they have been presented over time. In the context of over 10,000 years of cultural history in Ontario, what we have shared is only a small fragment of our province's mosaic. During Digital Doors Open, take time to explore some of many sites that help expand the narrative around Ontario's diverse heritage:

- The Chatham-Kent Black
   Historical Society and Black
   Mecca Museum is dedicated to the discovery, research, and preservation of the region's Black history. Check out their unique exhibits, including a website dedicated to the Chatham Coloured All-Stars baseball team.
- Myseum was made for Digital Doors
  Open! This Toronto museum exists
  throughout the city, and showcases
  the history, spaces and cultures that
  make up Toronto through digital
  exhibits or walking tours.
- The ArQuives was established to help recover and preserve Canada's LGBTQ2+ histories. It is the largest archive of its kind in the world. Explore their collections and artifacts, and learn more about the people who preserve them.
- The Mnjikaning Fish Weirs
   National Historic Site is a place that was cared for and used by the Huron-Wendat in the centuries before 1650. Today, the Anishinaabeg are stewards of the site. Check out a video about the history of this site, and its future.
- The <u>Saint Joseph's Indian</u> <u>Residential School Memorial</u> marks the site of the Thunder Bay residential school, and for Digital Doors Open, visitors can explore the history and legacy of Canada's residential school system through the stories and experiences of survivors.

- 3. **AND WHEREAS** the municipality provides accommodations to meet any stated accessibility need, where possible;
- 4. **AND WHEREAS** the declared pandemic, COVID-19, has impacted the finances and other resources of the municipality;
- 5. **AND WHEREAS** the Accessibility for Ontarians with Disabilities Act contemplates the need to consider the technical or economic considerations in the implementation of Accessibility Standards:
- 6. **BE IT THEREFORE RESOLVED THAT** the municipality requests that the Province of Ontario extend the compliance deadline stated in Section 14(4) of O Reg 191/11 to require designated public sector organizations to meet the compliance standards, by a minimum of one (1) year to at least January 1 2022; **AND**,
- 7. **BE IT THEREFORE RESOLVED THAT** the municipality requests that the Province of Ontario consider providing funding support and training resources to meet these compliance standards."

The impacts of the pandemic on municipal finances and resources affect the ability of municipalities to meet the January 1, 2021 deadline for full compliance with WCAG 2 0 Level AA.

We humbly request the Ontario government consider an extension request, in addition to financial support and training due to the unprecedented impacts of the global pandemic

At its meeting of September 14, 2020, Council passed the following for your consideration:

#### Resolution # 20200914-258:

"WHEREAS Royal Assent has been granted to Bill 108 entitled 'More Homes, More Choice Act, 2019' on June 6, 2019; and,

**WHEREAS** Schedule 11 of Bill 108 contains amendments to the Ontario Heritage Act which require appeals under the Ontario Heritage Act to be heard by the Local Planning Appeal Tribunal not the Conservation Review Board; and,

**WHEREAS** the Conservation Review Board is an adjudicative tribunal that, through the mandate provided by the Ontario Heritage Act, considers a number of matters such as:

- The proposed designation of a property as having cultural heritage value or interest;
- Applications for the repeal of a By law on a specific property;
- Applications related to the alteration of a property covered by a By law; and,
- · Matters related to archaeological licensing. AND,

**WHEREAS** Schedule 11 of Bill 108 will come into effect on a date to be proclaimed by the Lieutenant Governor; and,

**WHEREAS** the Local Planning Appeal Tribunal are not experts in heritage matters unlike members of the Conservation Review Board; and,

**WHEREAS** the Local Planning Appeal Tribunal decisions are binding decisions unlike the Conservation Review Board non-binding recommendations; and,

WHEREAS the Ontario Heritage Act provides a means for municipalities to protect and preserve the cultural heritage value or interest of the municipality for generations to come; and, WHEREAS the Conservation Review Board currently provides reports to municipal council's setting out its findings of fact, and its recommendations so that a final decision can be rendered by municipalities about what is valuable in their community;

**WHEREAS** the Town of Amherstburg remains committed to the preservation and protection of property of cultural heritage value or interest;

**NOW THEREFORE BE IT RESOLVED THAT** the Town of Amherstburg strongly recommends that Schedule 11 of Bill 108 be amended to remove the powers provided to the Local Planning Appeal Tribunal, retaining authority for hearing certain appeals by the Conservation Review Board; and,

**BE IT FURTHER RESOLVED THAT** the Town of Amherstburg strongly recommends that Schedule 11 of Bill 108 be amended to return the authority for final decisions to municipal council's as the elected representative of the communities wherein the property and its features of cultural heritage value exist; and,

**BE IT FURTHER RESOLVED THAT** a copy of this motion be sent to the Honourable Doug Ford, Premier of Ontario, Lisa McLeod the Minister of Heritage, Sport, Tourism and Culture Industries, Andrea Horwath, MPP and Leader of the Official Opposition and the Ontario NDP Party, MPP John Fraser Interim Leader of the Ontario Liberal Party, Mike Schreiner MPP and Leader of the Green Party of Ontario, Taras Natyshak MPP Essex County; and,

**BE IT FURTHER RESOLVED THAT** a copy of this motion be sent to the Association of Municipalities of Ontario (AMO), all MPP's in the Province of Ontario, the County of Essex and all Municipalities in Ontario for their consideration."

We strongly recommend that the Ontario government consider amendments to Bill 108 to return the final authority to municipal Council's to determine what is of cultural heritage value or interest in their communities with the benefits of the expert and professional advice provided by the Conservation Review Board.

# AMO Policy Update – Provincial Regional Gathering Restrictions and DC/CBC Regulations

# **Provincial Gathering Restrictions and Increased Enforcement**

On Saturday, September 19<sup>th</sup>, the Ontario government announced the limit reduction on the number of people permitted to attend unmonitored and private social gatherings for the entire province. Last Thursday, the Province put these restrictions on for Toronto, Peel Region, and Ottawa.

This sets a new limit on the number of people allowed to attend an unmonitored social gathering or organized public event provincially to:

- 10 people at an indoor event or gathering (previous limit of 50); or
- 25 people at an outdoor event or gathering (previous limit of 100).

As was the case under the *Emergency Management and Civil Protection Act* (EMCPA), all police officers, First Nations Constables, and special constables may enforce orders that have been continued in effect under the *Reopening Ontario (A Flexible Response to COVID-19) Act*, 2020 (ROA). In addition, the following enforcement personnel are designated to enforce orders that have been continued in effect under the ROA:

- · all provincial offences officers designated by a minister of the Crown;
- all municipal law enforcement officers;
- · all by-law enforcement officers of a municipality or local board of a municipality;

 all officers, employees, or agents of a municipality or local board of a municipality whose responsibilities include enforcement of by-laws, Acts, or regulations.

# Decision Notices – Regulations for Development Charges and Community Benefit Charges

The Ministry of Municipal Affairs and Housing posted four decision notices on Friday (links are below). These are linked together for regulations on development charges (DC), community benefit charges (CBCs), and parkland dedication. These regulations were expected to be finalized following the passage of Bill 197 in July which outlined a new regime for development charges in Ontario.

#### Notable items from the decision notices include:


- The in-force date of September 18, 2020 starts the two-year transition period for municipalities to implement a new framework.
- The percentage of land value that determines the maximum community benefit charge is 4%. This percentage decreased from the previous regime which was expected. The Ministry states that this percentage was determined based on extensive feedback during their consultation; however, additional analysis is required to determine how it works for municipalities.
- Several other key details set out in CBC and parkland regulation within the *Planning Act* include:
- the percentage of land value that would determine the maximum community benefits charge payable
- o the timelines for land value appraisals where the CBC amount is disputed
- the types of development that would be exempt from community benefits charges
- the content requirements for a CBC strategy
- the notice requirements for passing a CBC by-law and a parkland by-law
- the interest rate for CBC and parkland refunds upon successful appeals to the Local Planning Appeal Tribunal (LPAT)
- the reporting requirements related to community benefits and parkland.
- Municipalities are required to annually prepare reports to provide information about the amounts in the community benefits charges and parkland dedication special accounts. This includes opening and closing balances, transactions, capital acquired, and other items outlined within the regulation.

As municipal governments make the shift toward this new regime, AMO will monitor the progress and highlight any issues that arise during the transition period. For full information and access the full decision notices on the Environmental Registry, click below:



OEB orders Hydro One to eliminate the Seasonal Rate Class

On September 17, 2020, the **Ontario Energy Board (OEB)** ruled that Hydro One will eliminate the Seasonal Rate Class, and shall move all customers into one of their other, density-based rate classes. This decision has been preceded by numerous rate applications and intervenor submissions by FOCA and others over the past five years.

FOCA remains extremely concerned about the financial impacts this change will have on the estimated 78,000 seasonal customers that will be moving to the R2 (low density) residential class and will face increases of \$60/month or more, based on Hydro One's last estimates. Read more here:







The decision made at the July 13 council meeting regarding my Lilac Hedge was very unfair. The decision was unfair because it was based on misinformation and assumptions — not true facts. The basic premise of the entire item discussed was incorrect. I wasn't requesting replacement of the hedge — just reimbursement for the MC Tree service fee I paid to repair the damage done to the Hedge (on private property).

A short history on this hedge. When we built the house there was a typical fencerow at the road, filled with various tree species. One evening, during a storm, one of the tall trees shorted out the hydro line and cut off power right back into Cannington. Ontario Hydro came and discussed replacing the fencerow with a Lilac Hedge because it is a low growing shrub and wouldn't interfere with the hydro line in the future **AND WOULDN'T SPREAD**. I agreed to this idea and they planted the hedge. Do you think Ontario Hydro would plant this hedge on Township property? **NO, NOT LIKELY**. It was planted 3.5 feet away from the road allowance boundary. Also, this hedge didn't spread. Yes, some branches bent and **TOUCHED** the adjacent road allowance but no part of the hedge grew on the road allowance. A Lilac Hedge isn't like a mature tree with branches 15 feet long growing horizontally. It grows vertically and spreads approximately 6 feet wide with no underground rhizome spread.

I got the impression from the council meeting video that my hedge had spread and was growing on the road allowance blocking the "line of site" as expressed by Mayor Bath Hadden. The only deterrent to line of site was, and is, the brush and tallgrass to the north and the south of this hedge. This brush and tall grass is growing to the edge of the road. When Ontario Hydro planted this hedge they also graded the road allowance and I planted grass which I mow a couple times each week. There is **NOTHING** growing on the road allowance except mowed grass. One might say that I'm helping alleviate the Township's strained budget for brush control by planting grass on Township property and cutting it.

As stated in my first letter there is an Ontario Hydro pole on the edge of the road allowance. Also, there is a Bell Canada junction box south of the hydro pole. This junction box is also near the edge of the road allowance. Judging by the position of my hedge, the hydro pole and the junction box both Ontario Hydro and Bell Canada responsibly determine the edge of the road allowance before doing any work. It's disappointing to learn that the Works Department doesn't. The procedure isn't time consuming and gives accurate guidance to employees out on the road doing the work.

Last fall we had telephone trouble. The Bell Canada technician came out, took the junction box apart to find a mouse nest inside. He never complained about or had to cut hedge branches covering the junction box yet the Township employee cut the hedge back about 2 feet behind this junction box **on my property**. The brushing to the South of the Hedge is 16 feet from the edge of the road. Brushing was done recently north of the Hedge and it is also 16 feet from the edge of the road. I also visited a couple other brushing jobs done in the Township and all were also 16 feet from the road edge. A new ditching project near Sonya extended 16 feet from the road edge. Why did the brushing of my hedge extend over 23 feet from the road edge?

The Invoice attached to my first letter was the cost to me to radically prune the mature damaged wood from the hedge. This mature Lilac Hedge would never have repaired the damage done with the Brush Machine. As a result of the pruning the hedge is looking healthy once again and will possibly bloom again in a couple years. I must say that I didn't ask MC Tree Service to "charge me whatever he wanted because Brock Township would be paying the bill". That was a very unfair statement by Mr. Lagrandeur. I asked MC Tree Service for a fair price and it was. It was a 2 day job for two men with chainsaws, 2 trucks and a wood chipper.

The final decision voted on was the Council "didn't want to set a precedent". To arrive at that very unfair decision you compared my hedge to a Cedar Hedge GROWING ON THE ROAD ALLOWANCE. My hedge is definitely not growing on road allowance, as described above, so the comparison is unfounded. I agree that you have the right to cut any overhanging foliage but is it necessary to cut a hedge back almost to it's centre when it's growing 3 ½ feet away from the road allowance on private property.

An interesting observation on the July 13 meeting. The two councillors who were kind enough to come out and observe the damage voted in my favour. I'm assuming they did so because they had the facts. I urge the other council members to come out (and talk to me) and also observe the facts so they can make an informed decision. My telephone number is (705)437-1262. ### **AMO Update:**

## 2020 Federal Throne Speech Lays Out Priorities Including Climate Action, Expanding Rural Broadband, Improved Housing Access, Child Care and Long-Term Care Standards

Her Excellency, Governor General Julie Payette, delivered the Trudeau government's <a href="Speech From The Throne">Speech From The Throne</a> today in the Senate. Throne Speeches lay out broad directions and priorities the government proposes to implement through legislation, policy, spending and other actions during the coming Parliamentary session. Prime Minister Trudeau will address Canadians regarding the priorities in the Speech later this evening.

The federal government is in a minority government situation and a Throne Speech requires the confidence of the House of Commons. This means that the government will require the support of opposition members to pass the Speech. The government and opposition parties will now be assessing the ability to pass the Speech.

Headline Speech commitments include expanding COVID-19 testing capacity to reduce delays; targeted financial support in the event of future localized lockdowns; and creation of 1 million jobs.

Significant commitments of interest to Ontario municipal governments include:

- Keeping the Canada Emergency Response Benefit (CERB) into 2021 and changing Employment Insurance in the long-term to include gig workers, the self-employed;
- Keeping supports such as the Canada Employment Wage Subsidy (CEWS) and the creation of a new disability benefit;
- Investments in infrastructure such as public transit and active transportation; flooding and fire prevention; clean energy and building energy efficiency upgrade supports; affordable housing and reduction of homelessness – including recent initiatives for rapid housing;
- Rural broadband expansion through "accelerating the timelines and ambitions" of the Universal Broadband Fund;
- Action on long-term care with national standards, supports for ageing in place and "Criminal Code amendments to explicitly penalize those who neglect seniors under their care;"
- Investing in a childcare and early learning system as well as creating a strategy for women in the economy;
- Banning single use plastics next year and improving recycling as well as creating a Canadian Clean Water Agency;
- Modernizing the Environmental Protection Act and legislating the goal of netzero energy emissions by 2030 as well as expanding electric vehicle charging; and
- Targeted support for travel and tourism, cultural and performing arts, and hospitality industries that have been hardest hit from the pandemic.

Of specific interest to municipal governments, the Speech promised action to continue municipal ability to ban handguns; expanding urban parks and access to greenspace and changes to improve civilian oversight of policing including the RCMP as part of its priority to reduce systemic racism.

Many of the items included in the speech were <u>proposed by AMO</u> to the federal and provincial government as investments that could help communities recover from the economic fall out of the pandemic. Municipal officials are encouraged to <u>watch or read the Throne Speech</u> to assess items of interest for their own communities. AMO will continue to analyze the Speech and monitor the progress of commitments made within it and report to members on relevant developments.

# AMO Policy Update – New Legislation, Regional Gathering Restrictions, and Pre-Federal Throne Speech Submission

#### **Provincial Legislation Introduction**

Minister Steve Clark, Municipal Affairs and Housing, has <u>introduced legislation</u> that will, if passed, provide a residential rent freeze and extend suspension of commercial evictions for 2021 as well as change the future management of the municipal electors' list. Although the actual legislation is not available at this time, we are able to provide the following details.

#### Rent Freeze for Residential Tenants

The Helping Tenants and Small Businesses Act would, if passed, freeze rent in 2021 over a one-year period for tenants of most rent-controlled and non-rent-controlled residential units. This includes municipally funded community housing rental units.

#### Suspension of Commercial Evictions

The Bill, if passed, would change the *Commercial Tenancies Act* to extend the temporary ban on evictions for commercial tenants. The ban will prevent small businesses from being locked out or having their assets seized during COVID-19.

#### Municipal Electors' List

Minister Clark also announced legislation to change the *Municipal Elections Act* and *Elections Act* to create one unified Electors' List for provincial and municipal elections which will be in place for 2024 and subsequent municipal elections. The Minister first announced the intention to move forward with a single list in October 2019. Challenges with the Electors' List for municipal elections have been identified for some time, making election campaigns and administration more difficult for candidates and municipal staff. The proposed changes should reduce duplication and efforts by municipal elections officials to verify information and improve the voting experience for the public.

AMO will review the legislation once publicly available and will provide updates to members when required.

#### Regional Gathering Restrictions and Increased Enforcement

The Ontario government has amended order O. Reg 364/20: Rules for Areas in Stage 3 under the Reopening Ontario (A Flexible Response to COVID-19) Act, 2020, to set a new limit on the permitted number of people to attend social gatherings and organized public events in the Toronto, Ottawa, and Peel Region public health unit areas that have higher rates of transmission of COVID-19. This includes functions, parties, dinners, gatherings, BBQs, or wedding receptions held in private residences, backyards, parks, and other recreational areas.

This amended order sets a new limit on the number of people allowed to attend an unmonitored social gathering or organized public event in three specific regions to:

- 10 people at an indoor event or gathering (previous limit of 50); or
- 25 people at an outdoor event or gathering (previous limit of 100).

Additionally, to increase compliance with public health guidelines, both within these three regions and across Ontario, amendments to the *Reopening Ontario (A Flexible Response to COVID-19) Act* would, if passed, create:

- a new offence regarding hosting or organizing a gathering in residential premises or other prescribed premises that exceeds limits under an order
- a minimum fine of \$10,000 for organizers of these gatherings
- authority for the Lieutenant Governor in Council to prescribe additional types of premises for the purpose of the new offence
- authority for a police officer, special constable, or First Nations constable to
  order the temporary closure of a premise where there are reasonable grounds
  to believe that any gathering exceeding the number of people allowed is taking
  place and require individuals to leave the premises.


