If you satisfy all the requirements, a \$350.00 Tax Rebate credit will be applied to your tax account at the end of the year being applied for. **Do Not** reduce your payments by this rebate amount or late payment fees will apply to any unpaid balance.

Once you have applied for this rebate an application will automatically be mailed to you annually with your Final Tax billing. The application for the rebate must still be applied for every year. If you do not receive an application with your Final billing, please contact the Treasury office to obtain one. New – visit our new website www.townshipofbrock.ca, and complete your application online if you have the ability to attach a copy of your GIS renewal letter electronically. Applications filed electronically will receive a reply email as their receipt of submission. ** NOTE: The Guaranteed Income Supplement program is administered by Human Resources Development Canada (HRDC) in conjunction with the Old Age Security Pension.
