- 6. Details of the animal's housing, including the location and construction materials.
- 7. Details on the animal's feeding habits and how the animal is to regularly feed; and where applicable, details of the proposed use or outdoor activities of the animal, including methods of controlling and securing the animal.
- 8. A copy of an emergency and safety plan for each animal (including emergency contact list, appropriate handling procedures, safety equipment, and a detailed diagram of the location of each prohibited animal on the premises, including entrances and exits).
- 9. Where the applicant is a business the following must also be provided:
  - a) Name, location and owner of business;
  - b) Name of all employees/volunteers associated with the business;
  - c) Type of business;
  - d) Must demonstrate why prohibited animals are required for the continued operation of your business;
  - e) Must demonstrate that the prohibited animals are required for the purposes of education.
- 10. Where the applicant is an animal sanctuary the following must also be provided:
  - a) Name, location and owner of sanctuary;
  - b) Name of all employees/volunteers associated with the sanctuary;
  - c) Mission statement of the sanctuary;
  - d) Charitable Registration Number.
- 11. The applicant shall contact the Township of Brock for inspection appointments of their facility by the Fire Department, By-law Enforcement/ Canine Control Department and the Provincial Animal Welfare Services (PAWS)
- 12. Payment of the sum of one half the applicable fee shall be payable upon submitting this application, the sum of which shall be applied to the license fee as set out in the Township of Brock Fees By-Law.
